Asset management is an area which lends itself to considering various options not just whether to spend more or less. Various Councils across Australia are becoming skilful in how they manage assets but I don't see that come through in what Lithgow is looking to do. The information provided on which to respond to this survey is rather limited. I would like to see what options are before council on each asset class eg. internal process or in-field improvements, sell-offs, technology based delivery, incentive based outsourced service delivery, etc.
